# CA Treasurer's Office California Captial Access Program

The California Treasurer's Office announced a <u>supplemental contribution</u> to the <u>California Capital Access Program</u> for businesses directly impacted by COVID-19. The Californa Capital Access Prorgram (CalCAP) was created in 1994, and is run by the California Pollution Control Financing Authority (CPCFA). The program encourages banks and other financial institutions to make loans to small businesses that have difficulty obtaining financing.

# Payroll Tax Assistance

Employers experiencing a hardship as a result of COVID-19 may request up to a 60-day extension of time from the EDD to file their state payroll reports and/or deposit state payroll taxes without penalty or interest. A written request for extension must be received within 60 days from the original delinquent date of the payment or return. For questions, employers may call the EDD Taxpayer Assistance Center:

# Unemployment Insurance (UI) Work Sharing Program

Employers facing the possibility of laying off workers can apply for the Unemployment Insurance (UI) Work Sharing Program if reduced production, services, or other conditions cause them to seek an alternative to layoffs. The Work Sharing Program can help minimize the need for layoffs, retain trained employees and quickly prepare for when business conditions improve, as well as avoid the cost of recruiting, training and hiring new staff. It also helps employees whose hours and wages have been reduced keep their current job, receive UI benefits and avoid financial hardships.
