The EOA Incentive Program is to encourage the redevelopment of a vacant property or building with grants for site and building improvements, business expansion or moving costs, development fees or costs of required public improvement projects:

Site Improvements: Paint, awnings, doors, windows, walls, siding, roofing, sidewalks, parking lots, landscaping, lighting, signs, outdoor dining spaces, fencing, shade structures, electrical, plumbing, air conditioning, heating, accessibility, safety issues, equipment, furniture or fixtures.

Relocation/Expansion/Development: Property acquisition costs, real estate costs, rental/lease reimbursements, new business permit fees, building permit fees, sewer and water connection fees, transportation impact fees, planning/use fees, and moving costs.

The grant requires the creation of at least one (1) new full-time job for a \$5,000 grant and at least one (1) new full-time job created for each \$10,000 after the initial one.

Grant applicants must either be the business owner or leaser with (3+) year lease with permission from the owner to make improvements. Applicants can have no active investigations pending for violation of city code or criminal investigation. Renovation must be completed within (6) months of Grant Funded agreement. All eligible activities and costs will be funded on a reimbursement basis. Activities under this grant may be subject to California's prevailing wages. Some types of businesses do not qualify for this funding.
