If you have lost work or have had your hours reduced we encourage you to apply for Employment Development Department (EDD) Unemployment Insurance (UI). In California Governor Newsom has waived the one-week waiting period for benefits and is looking at expanding UI claim offerings. Please use this guide to apply for financial support.

## (3) WAYS YOU CAN ACCESS FUNDS



### **UNEMPLOYMENT INSURANCE**

May Receive **\$40-\$450 per week**, up to **26 weeks**

#### **This is the best option for you if:**

You have lost your job or have had your hours reduced for reasons related to COVID-19

**Available to** full-time or part-time workers



### **PAID FAMILY LEAVE**

May Receive **Approx. 60-70% of wages**, based on income **\$50-\$1,300 per week**, up to **6 weeks**

#### **This is the best option for you if:**

You're unable to work because you are caring for an ill or quarantined family member with COVID-19, as certified by a medical professional



### **DISABILITY INSURANCE**

May Receive **Approx. 60-70% of wages**, based on income **\$50-\$1,300 per week**, up to **52 weeks**

#### **This is the best option for you if:**

You're unable to work due to medical quarantine or illness related to COVID-19, as certified by a medical professional

## OTHER RESOURCES

- **PAID SICK LEAVE LAW** provides time off to many workers. You are entitled to use whatever sick leave you have accumulated.
- If you were exposed to COVID-19 while on the job and in the course of your regular duties, you may also qualify for **WORKERS' COMPENSATION**
